Your child may be photographed during this event and the photographs may be used for positive press coverage by any of the event's partnering organizations, including Meadowlands Transportation Brokerage Corporation d/b/a EZ Ride, and Farmingdale Public School.

No student will be permitted to participate without this executed permission slip and waiver/liability release being on file prior to the event. Students who have an executed permission slip and liability release on file, but whose photographs are not permitted, will be allowed to participate in the event.

As the minor's parent and/or legal guardian, you must understand the nature of bicycling and the minor's experience and capabilities related to bicycling and believe the minor to be qualified, in good health and in proper physical condition to participate in such activity. By signing this form, you agree to release, discharge, covenant not to sue, agree to indemnify and hold harmless each of the partnering organizations (Meadowlands Transportation Brokerage Corporation d/b/a EZ Ride, and Farmingdale Elementary School) from all liability, claims, demands, losses or damage to the minor and his/her property caused in whole or in part by the negligence of the partnering organization and further agree that if a claim is made against any of the partnering organizations by the minor or anyone on his/her behalf, you will indemnify and hold harmless each of the partnering organizations from any litigation expenses, attorneys' fees, loss liability, damage or cost any may incur as a result of such claims.
